Dear Ms. Towey:

In accordance with Chapter 4, Article 1.1 of Title 32.1 of the Code of Virginia of 1950 (the Code), as amended, I reviewed the application and all supporting documents submitted by Wellmont Health System d/b/a Norton Community Hospital to establish a long-term care unit at Norton Community by certifying 10 licensed hospital beds for long-term care.

As required by Section 32.1-102.3B of the Code, I have considered all factors that must be taken into account in a determination of public need, and I have concluded that **approval** of the request is warranted based on the following findings:

- 1. The project is generally consistent with the applicable criteria and standards of the State Medical Facilities Plan and the eight Required Considerations of the Code of Virginia.
- 2. The proposed project is more advantageous than the status quo.
- 3. The proposed project appears to be financially feasible in the immediate and the long-term.
- 4. There is no known opposition to the proposed project.
- 5. The proposed project is not likely to have a significant negative impact on the costs, utilization, or staffing of existing area providers.

SCOPE OF PROJECT: Establish a long-term care unit at Norton Community Hospital by certifying 10 licensed hospital beds for long-term care. Norton Community Hospital's authorized number of licensed beds will remain at 118. Capital costs associated with this project total \$191,348. The project is expected to be completed by July 1, 2023
