Dear Ms. Norkus:

This letter acknowledges the September 2, 2025, receipt of your application for the project referenced above. We received check no 696660 for \$20,000 in full payment of the COPN application fee. Based on the review of your application and receipt of the appropriate application fee, the Division of Certificate of Public Need (DCOPN) has concluded that the application is reasonably complete. The project is accepted for review in batch cycle D/G beginning November 10, 2025. Please note that there is no organization in Health Planning Region III designated by the Virginia Department of Health to serve as the health planning agency for Planning District 5. In the event that there is a written request by an elected local government representative, a member of the General Assembly, the Commissioner, the applicant, or a member of the public, DCOPN will conduct a public hearing at a date and time to be determined.

DCOPN is scheduled to issue its staff report by January 20, 2026. In accordance with 12 VAC 5-220-230, A of the Virginia Medical Facilities Certificate of Public Need Rules and Regulations, within four days of the issuance of its staff report, DCOPN will determine whether it will be necessary to convene an informal fact finding conference (IFFC) for reconsideration of recommendations made by DCOPN. Should it be necessary to convene an IFFC, the IFFC will be conducted on Friday, February 6, 2026, beginning at 2:00 p.m. in Training Room 1 of the Perimeter Center located at 9960 Mayland Drive in Henrico, Virginia. Should an IFFC not be convened, the State Health Commissioner will make a final decision on the project by March 10, 2026.


